The Council of the Village of Millbury met in regular session on the above date at the Millbury Council Chambers with Mike Timmons, Mayor, presiding.

Council Members present: Clapsaddle, Mangus, Mikolajczyk, Sanders and Schwamberger.

Motion by Mikolajczyk to approve the mayoral appointment of Larry Ellison to the Village of Millbury Council. Seconded by Mangus. Roll Call: all yea! Motion carried.

Motion by Sanders to approve the July 14, 2025 meeting minutes. Seconded by Schwamberger. Roll Call: all yea! Motion carried.

Police Department: per Lake Township Police Officer
